Emergency overview

Immediate concerns: WARNING! COMBUSTIBLE LIQUID AND VAPOR. INHALATION CAUSES HEADACHES, DIZZINESS, DROWSINESS AND NAUSEA AND MAY LEAD TO UNCONSCIOUSNESS. CAUSES SKIN IRRITATION. HARMFUL OR FATAL IF SWALLOWED. CAN ENTER LUNGS AND CAUSE DAMAGE.

Potential health effects

Eye: Moderately irritating to eyes.

Skin: Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

Ingestion: POISONOUS. May be fatal or cause blindness if swallowed. Ingestion may have a narcotic effect including signs of CNS depression such as dizziness, headache, drowsiness, loss of coordination, and fatigue.

Inhalation: Excessive exposure to this product may cause headache, CNS depression, drowsiness, dizziness, loss of appetite, irritation of the respiratory tract, drunkenness, unconsciousness, or death.

Medical conditions aggravated: Preexisting diseases in or history of ailments involving skin, central nervous system, liver and kidney.

4. First-aid measures

Eye: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention.

Skin: Remove contaminated clothing/shoes. Flush skin with water for at least 15 minutes. Follow by washing with soap and water. If irritation occurs, get medical attention. Do not reuse clothing until cleaned.

Ingestion: Call poison control center or get medical help immediately. If patient is conscious and alert, give 8 ounces of water or juice and induce vomiting, keeping patient's head below hips to prevent aspiration of liquid into lungs. Never induce vomiting on an unconscious person.

Inhalation: Remove to fresh air. If not breathing, give artificial respiration or give oxygen by trained personnel. Seek immediate medical attention.

Acute effects: Shortness of breathing, confused behavior, redness of skin, swelling of tissues, watery eyes, and nausea.

5. Fire-fighting measures

Suitable extinguishing media: Use water fog, "alcohol" foam, dry chemical, or CO₂.

Hazardous combustion products: Carbon monoxide and unidentified organic compounds may be formed during combustion.

Explosion hazards: When heated above the flash point, this material emits flammable vapors which, when mixed with air, can burn or be explosive. Fine mists or sprays may be flammable at temperatures below the flash point.

Fire fighting procedures: WARNING! Flammable Liquid. Clear fire area of unprotected personnel. Do not enter confined fire space without full bunker gear, including a positive pressure NIOSH approved SCBA. Cool fire exposed containers with water.

6. Accidental release measures

General procedures: WARNING. Combustible. Ventilate area of leak or spill. Remove all sources of ignition. Clean-up personnel require protective clothing and respiratory protection from vapors. Only specially trained or qualified personnel should handle the emergency.

7. Handling and storage

General procedures: Keep away from heat, sparks, and flame. Surfaces that are hot may ignite even liquid product in the absence of sparks or flame. Extinguish pilot lights, cigarettes and turn off other sources of ignition prior to use and until all vapors are gone.

Conditions for safe storage: Store away from heat, sparks, and open flame. Keep containers tightly closed when not in use. Do not weld, cut, grind, solder, or drill on or near empty containers. Empty containers may contain explosive concentrations of product vapors.

Eye / face protection: Chemical goggles/face shield.

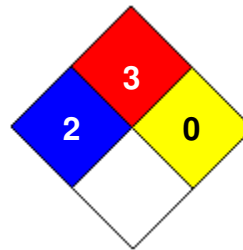
